UNFINISHED BUSINESS

10.1 131 Main Street

The Village is still accepting demolition bids until the end of the month. Still only have one bid.

10.2 Village Hall Maintenance/ Roof/ Garage Door Frames - Estimates

Overhead Door estimates are in the packets. There are two estimates – one to wrap the door jambs in metal for \$3,966. and one to remove the brick between the Fire Department doors and replace it with metal siding for \$3,646. The previous bid from M. Grinnell was to replace the boards with Trex plastic composite. A. Flynn mentioned that Jim Jarred is a brick layer here in town who could possibly replace the brickwork. H. Bradberry will check with him for an estimate.

10.5 Sewer Lagoon Valve Repair

T. Scott reported at S. Hughes, the lagoon operator, has gotten quotes from Eifert to repair the valves in pond 2. They will charge \$2,500 labor per day and estimate that the job will take up to 2 days. The valves are \$1,400 each and there are 3 that need to be replaced. Estimated project cost is \$9,200.

MOTION by P. Hruska, second by A. Flynn to approve spending up to \$10,000 to replace the valves.

10.6 Morrice Road Repair

T. Scott explained the change order received from the engineers. The estimated cost to have TomCo repair Morrice Road while they are here is \$9,000. They will grind it down 2 inches and resurface the lane, 12' wide by 180' long. R. Peterson commented that the whole road needs to be done over rather than just the bad spot. There was discussion including the actual condition of the road, the engineers, the previous contractors, and a possible lawsuit.
